

**2026 REQUIREMENTS FOR APPLICATION TO CONDUCT PROCUREMENT AND DISPOSAL OF PUBLIC ASSETS IN TERMS OF THE PUBLIC PROCUREMENT AND DISPOSAL OF PUBLIC ASSETS (PPDPA) ACT [Chapter 22:23]**

1. All Accounting Officers, in terms of section 14 of the PPDPA Act are responsible for public procurement and every Procuring Entity (PE) that conducts procurement is required to apply for authorisation to conduct procurement in order to be compliant with the provisions of section 15 of the same Act. Further to that, section 65 (2) of the PPDPA (General) Regulations requires the Accounting Officer to come up with a Disposal Plan.
2. Section 6 (e) & (f) of the PPDPA Act mandates the Procurement Regulatory Authority of Zimbabwe (the Authority) to develop the use of electronic tools for procurement, including a public procurement website and statistical databases containing information on public procurement in Zimbabwe, and specify the conditions under which such databases will be availed to the public; and to enable the publication on the website documents that are required to be published by procuring entities.
3. The Authority wishes to advise that the templates for submission of applications to conduct procurement and disposal of public assets for the year 2026 have been modified to align to with market conditions. The modified templates can be accessed on the Authority's website [www.praz.org.zw](http://www.praz.org.zw).
4. The Authority in view of the above and in terms of section 7 of the PPDPA Act hereby directs all Accounting Officer's to prepare and submit 2026 applications to conduct procurement and disposal of public assets as per the modified templates and attached requirements for authorisation to conduct procurement.
5. Procuring entities are encouraged to ensure that applications to conduct procurement and disposal of public assets and relevant attachments are uploaded on the eGP system link <https://egp.praz.org.zw> by 31 January 2026 to avoid inconveniences on procurement processes.
