

Public Procurement and Disposal of Public Assets (General)
(Amendment) Regulations, 2026 (No. 5)

IT is hereby notified that the Vice President, after consultation with the Minister of Finance, Economic Development and Investment Promotion and the Authority, in terms of section 101 of the Public Procurement and Disposal of Public Assets Act [*Chapter 22:23*], has made the following regulations:—

1. These regulations may be cited as the Public Procurement and Disposal of Public Assets (General) (Amendment) Regulations, 2026 (No. 5).

2. The following regulations are repealed—

- (a) the Public Procurement and Disposal of Public Assets (General) (Amendment) Regulations, 2020 (No. 1), published in Statutory Instrument 49 of 2020; and
- (b) the Public Procurement and Disposal of Public Assets (General) (Amendment) Regulations, 2021 (No. 3), published in Statutory Instrument 299 of 2021.

3. The Public Procurement and Disposal of Public Assets (General) (Amendment) Regulations, 2018, published in Statutory Instrument 5 of 2018 (hereinafter referred to as the “principal regulations”), are amended by the repeal of the Fifth Schedule and substitution of the following—
